Please share the following with the AAFA Board and Membership as it recounts items of interest that arose during the month of October and looks forward to certain events occurring in upcoming months.

**Follow-up on August's upcoming events:**

1. October 17 – 19 – MSE Workshop on North Pacific Albacore. While we were unable to attend, we did participate in the pre-Workshop US delegation call. A 15-page DRAFT Report covering the meeting results. We will review and submit a separate analysis at a later date.

**Federal Register Items of Interest:**

In past reports we have highlighted actions taken against Canadian importers and industry by the International Trade Administration of the Department of Commerce and The United States International Trade Commission. The intent was to show how there are some tensions between the two Nations on certain trade issues. Rather than take up space delving into each – we will simply list the publication date in the Federal Register, the topic of the publication and provide a link if the reader wishes to learn more about the publication.

1. October 4 – NMFS issues notice of a test and a request for comment on the electronic submission of certain data required under the Seafood Import Monitoring Program. The notice is unclear how one not participating in the test would be able to comment, or even what they would comment on. See -

2. October 12 – NMFS publishes the draft List of Fisheries for 2018 (LOF). The LOF classifies every US fishery based on its level of interactions with Marine Mammals – and is required by the Marine Mammal Protection Act. As you can imagine, the “WA/OR/CA albacore surface hook and line/troll” fishery (with 705 participants) is proposed to be a Category III fishery with no documented interactions with any Marine Mammals. Other fisheries AAFA members participate in: “WA coastal Dungeness crab pot”; “OR Dungeness crab pot”; “CA Dungeness crab pot” and “CA thresher shark/swordfish drift gillnet (≥14 in mesh)” are all propose to be Category II fisheries. There are no Category I fisheries off the US West Coast except the “HI deep-set longline” fishery. All others are Category III. See - <https://www.gpo.gov/fdsys/pkg/FR-2017-10-12/pdf/2017-21837.pdf>
3. October 24 – NMFS seeks comments on logbook used in the “Pacific Hook and Line fishery” These comments can be limited to the current logbook, or could include comments on what we would like to see in the logbook. #### **Other items of interest:**

1. *Canning operations in Oregon impacted by slow albacore season*. Short supply leads to reduced canned product for two local canneries: Northwest Wild Products and Sportmen’s Cannery. See - <http://www.dailyastorian.com/CRBJ/20171010/canning-conundrum-slow-tuna-season-cuts-cannery-production>
2. *Closure of Spanish fishery for Atlantic albacore*. Estimated that by Oct 13, the quota of 14,196,152 kilos (roughly 15,650 tons) will be exhausted. See - <http://www.fis.com/fis/worldnews/worldnews.asp?l=e&country=0&special=&monthyear=&day=&id=94217&ndb=1&df=0>
3. *WTO Dolphin-Safe Tuna labeling*. The World Trade Organization rules in favor of US in ongoing dispute with Mexico over its dolphin-safe tuna labeling requirements. Changes, made by the US in 2016, “either removed discriminatory treatment to Mexican tuna products or were justified as exceptions to WTO rules on the grounds they were necessary for the conservation of exhaustible natural resources.” See - <http://thehill.com/policy/finance/357437-us-wins-trade-case-over-dolphin-safe-tuna-labeling>
4. *Fatality on California squid seiner*. Freak accident resulted in death of a crew member. The mast on the Pamela Rose snapped and fell onto the vessel’s deck. This is included because it highlights that things we don’t normally check (masts, etc) can be compromised. Not sure how the USCG will respond in terms of vessel inspections; but one thing we have heard being discussed is requiring inspection plates on masts in order to detect if there is any rust. I have spoken to a number of purse seine vessel operators; and very very few even thought of checking the structural integrity of their masts prior to this event. 5. *Meeting of the Permanent Advisory Committee (“PAC”) to the Western and Central Pacific Fisheries Commission*. The PAC met on October 24 and 25. Natalie attended as she is now a Committee member. We reviewed the Agenda and meeting materials in advance of the meeting; and didn’t think the North Pacific Albacore fishery was a primary topic of conversation.

1. November 14 – 20 - Pacific Fishery Management Council meeting to be held in Costa Mesa, Ca. Proposed Agenda has nothing on it related to albacore; but I imagine a review of the MSE workshop will be discussed.
2. December 2 – 7 – Annual meeting of the Western and Central Pacific Fisheries Commission. Provisional Agenda attached at Attachment 1.
3. December 5 – West Coast Regional Planning Body Annual Meeting. This meeting will discuss coordination, policy and planning for our West Coast ocean. I was invited to participate and will surely attend.
